APPLICATIONS:

- There is **NO FEE** to enter the Riverton Town Days Parade if you are a Riverton resident or business. There is a **\$20 FEE** for a non-Riverton business.
- Parade entries are limited to the first 90 entries. No entries will be taken after the parade is full, please submit your application early.
- **Waiver and Release of Damages:** Enclosed are several Waiver and Release of Damage forms. These forms must be filled out by **every participant** that will be driving, riding or walking with your entry. Please turn these in with your application. No exceptions. Please make copies as needed.

- **All applicants will receive a confirmation e-mail sometime after June 19 and before June 29.** This email will include your parade number, map of parade route, line-up, check-in details & etc. **Please ensure you put the name & e-mail address you would like this packet sent to on your application.** Please note: If the parade is full or your application is denied we will notify you ASAP!

- Absolutely no applications will be taken after the deadline date.
- There will be no Judging or Awards.
- Riverton City reserves the right to deny an application if we determine an entry to be controversial, unlawful, or otherwise considered to be inconsistent with the standards or the purpose of the Riverton City Town Days Parade.

RESTRICTIONS AND CONCERNS

- **Water guns, & water balloons are prohibited.**
- **All Entries must provide a spotter on both sides of entry**
- **We encourage walkers to be at least 10 years of age.**
- **Marching Bands** need to have designed routines that have **constant forward movement** following their entry. This will avoid large breaks in the parade.
- **Candy:** participants are allowed to throw candy, but please follow these guidelines: 1) Candy **MUST** be individually wrapped. 2) We **recommend** entries who are throwing candy be at least 10 years of age and walk along side the street to ensure the candy is thrown into the crowd, not into the street. 3) If participants are throwing from a vehicle, please ensure they are throwing the candy far enough away from the vehicle that children aren't at risk by having to come too close to vehicle to pick it up. No candy will be thrown past the rodeo arena (12800 S 1450 W).
- **ATV's, Motorcycles, Golf Carts:** Participants are welcome to include ATV's, motorcycles, golf carts with their entries, but please note: 1) participants must obey all laws and regulations regarding motorized vehicles, failure to do so could result in a citation from local law enforcement and denial of any future parade applications. 2) We recommend participants wear proper safety gear. 3) **Riverton City reserves the right to deny any entry we determine to be unsafe.**
