License Renewals are due every year on the anniversary month that your license was issued. Your City Business License will indicate an expiration date. **A renewal notice will be sent as a reminder. HOWEVER,** you are ultimately responsible for ensuring **timely** renewal payments. Delinquent renewals will be assessed penalties (percentages are based on the applicable business license fee) as follows: 25% if 30 days past due; 50% if 60 days past due; and 100% if 90 days past due. We require a signature on all Business Closures.

This form is an application for a business license, the actual license will be issued when all inspections are received/approved. All information must be accurately completed or the issuance of licensing will be delayed. Your license must be displayed prominently at your place of business.

It is a class B Misdemeanor to own or operate a business in Riverton City without a business license.

I/We hereby agree to conduct said business strictly in accordance with the Laws and Ordinances covering such business and swear under penalty of law the information contained here is true.

I/We have read a copy of the Rules and or Ordinances regarding Business Licensing. I understand that my business may be checked periodically for ordinance compliance.
